GENERAL TERMS AND CONDITIONS FOR e-AUCTION

- The auction purchaser should be a Citizen of India.
- EMD amount for all sites is Rs. 1.00 Crore, except CS-1A, which is Rs. 2.00 Crore and this amount along with the e-Auction fee should be remitted as mentioned on the e-Procurement portal. 5% Service charge on EMD shall be deducted during refund if remitted to BDA's account instead of E-Auction portal.
- Advice letters will be sent by e-mail to successful bidders (Highest bidders) to remit 25% of the total cost after deducting EMD amount. Remittance challans should be submitted to Chief Accounts Officer, Finance Department, D Block 2nd Floor Room number 308. In case of failure to remit 25% as mentioned in the advised letter, EMD shall be forfeited.

NRI's interested in participating in the e-auction may do so by uploading self attested certificates. Successful bidders can submit certification issued by Indian Embassy later.
- Successful bidders after remitting 25% of the final bid amount should pay the balance 75% amount within 45 days of receiving the allotment letter from BDA.
- EMD amount of unsuccessful bidders will be credited to their Account within 30 working days.
