- Successful bidders shall pay 10 months rent within 7 days after the acceptance of their bid by the Competent Authority (successfully quoted bid). Failing to pay the same within stipulated time, EMD shall be forfeited.

- The auctioned Shops will be allotted to the successful bidders in the same condition as they are. Bidders participating in the e-auction must physically check the shop before bidding. Shops allotted in the e-auction will not be cancelled / substituted.
- Bidders participating in e-Auction are meant to adhere to all the terms and conditions specified above.
